Planner Erin Besch reviewed next steps, with draft Official Plan Amendments and draft Zoning By-law Amendments at a future Public Meeting in March 2020 for Council to review.

Planner Erin Besch advised Council and the public in attendance that there is a twostep process for approving Official Plan Amendments. First step is approval from Township Council, second step is approval from the delegated authority, which is County of Middlesex Council.
