
Kerwood Park Improvements

Phase 2

Project Summary

The Township is looking to improve Kerwood Park through:

- New facility / community space
- Improved accessibility throughout
- Construct accessible washrooms
- Refresh existing amenities
- Encourage new park related activities

Project Approach

- Phased in over two years
 - Ensure the park is still usable for outdoor activities during construction
 - Leverage additional funding opportunities
- Phase 1: Finalize facility, including any work related to the pavilions
- Phase 2: Refresh of ball diamonds, dugouts, lighting, bleachers, parking lot, aesthetics and landscaping

Phase 1: Almost Complete

- New pavilion
- Two accessible washrooms
- Kitchenette
- Mechanical room
- Equipment storage

 Remaining: some grading, resolve any deficiencies, final walk-through



Phase 2: Site Works

- Ball diamonds, including fencing
- Dugouts
- Baseball diamond lighting
- Bleachers
- Parking lot
- Aesthetics and landscaping
- Outdoor Ice Rink

Phase one of the Kerwood Park Improvements is scheduled to be completed by the end of 2021 for the washroom, storage and pavilion upgrades. Budget Survey Responses – Park Amenities

Summarized Ideas Include:

Fencing for the diamonds and maintenence on the infields

Woodchips for playground equipment

Improvement to grass and weed control

Accessible playground equipment (kids & adult)

Soccer field

Tennis court

2nd set of lights for back ball diamonds.

Sidewalks/walking paths

Better lighting

New swings

Splash pad

Upgrade sports equipment.

Solar education signage with roof panel and charge plug ins

Drinking water fountain or bottle filling station

Exterior upgrades to storage barn

Full improvement to ball diamonds

Review overall park design to include accessibility

More trees

(NEW) Phase 3 – The Barn

- Engineer's report completed of the structural integrity of the building
 - Discuss primary findings
- Cost prohibitive to undertake at this time
- Proposed to defer to budget 2023
- Potential options
 - Repair
 - Tear down and replace with a similar or smaller facility, maintain services in building
 - Tear down and move all services (water/hydro) to washroom facility
 - Other?

Timing and Service Levels

- Applied for a number of grants in 2021
 - Seniors, Accessibility and Community Development
 - Grant applications were not successful, unfortunately
- Delayed planning of Phase 2 as each grant came with a different scenario that would have affected planning and budget requirements
- Phase 2 to start in the fall after community events and park rentals are completed
- Increase service levels at the park
 - Park maintenance, including facility cleaning, garbage removal, grass cutting, etc.
 - Require new equipment (grass cutting, dragging the ball diamonds)
 - Address public feedback regarding park maintenance
 - To be further discussed during budget
